## **REGULAR CONTACT WITH LOCAL AND STATE OFFICIALS**

The board visits the Park Manager and the District Forester on a regular basis for information on changes and events. A liaison from DCNR in Harrisburg talks regularly with Board members to inform the Association of statewide changes and to allow for input favorable to cabin ownership.

## **LEGISLATIVE TRACKING**

The Board monitors proposed legislation and writes or visits legislators or testifies before appropriate panels and commissions when such proposals seem impractical or incompatible with cabin living.

## **CABIN SECURITY**

As a member, your cabin is checked monthly (in the off-season more than once a month) for break-ins, broken pipes or lines, downed trees, and other problems that might exist. If our cabin inspector finds something amiss you will be notified. **Where else could you find someone to inspect your property on a monthly basis for just \$50 a year? Membership is well worth this peace of mind. Join the MFA community!**
